The following are the terms that DJ Fanch Productions and the client agree upon.

Services Rendered By DJ Fanch Productions.

Services that DJ Fanch Productions provides are based on certain factors. Upon our arrival to your venue of your choosing we will determine the best setup for the event. All venues are not the same. We ask that when planning your wedding that you consider enough room for us to set up equipment. We ask that we have space no less than 15X10. This gives us adequate space to place equipment for your event. We provide professional sound and lighting packages no matter what level of service you provide. We will show up at least Three hours prior to the start of your event to insure all systems are functioning properly. We provide wireless microphones for blessing and toasts as well. After we have our meet and greet to determine all of your request we will begin to plan for your event. After planning is done we will perform at your venue

on your wedding date and perform all service to the best of our ability. If equipment were to fail we have backup equipment on hand to ensure event keeps running smoothly.

#### Liability, incidents and Acts of God.

In the case of bad weather or an act of God we reserve the right to stop all activities until the weather clears or cancel the event if the lives or property of others is in immediate danger. If there is an incident that may cause harm to others or to the DJ we reserve the right to stop services or cancel event if the incident cannot be resolved. All of these will be under consideration of the DJ and we will make the decision that is best for all involved. If the event is canceled due to weather we will happily DJ another event for you for a lesser fee. If for any reason a fight or incident between guest occurs or the DJ working your event is harassed or physically harmed we reserve the right to stop services and end your event. Guests that cause issues with the DJ will be asked to stop. If they fail to do so we ask that the person be escorted out of the venue so that your event may continue to run as planned. All fees will be forfeited and proper authorities may be contacted. We are not to be held liable for any damages that may occur unless they are cause by our company. This includes damages from you or your guest. If for any reason we are unable to provide services for your event we will work to find a replacement DJ or refund your cost of services to accommodate services not being rendered.

#### Communication.

We require you to fill out forms that we provide from our booking website. These are meant to help us with all of the planning phases of your event. We also prefer a meet and greet no less than 30 days prior to your event to discuss all the details and any special requests you may have for your event. We will do our best to accommodate any special request you have. We will from time to time reach out to you and ask if you have any questions or concerns for your event. We feel that communication is key to a successful event.

#### Payment Terms.

All events require a deposit and a signed contract to secure your date. All deposits are non-refundable. If you change your date of your event your deposit may be transferred if the new date is available. Your date is not secure until we have received your deposit.. We do not accept checks only Cash or Credit Card. Failure to do so will result in your event being delayed and not starting on time. We send out reminders prior to final payment being due as a friendly reminder to ensure the event runs smoothly and On time. The full balance must be collected no later than five (5) days prior to your event unless prior arrangements have been made. If the full balance is not collected before your event it will not start as scheduled. This may cause conflicts with your venue and wedding party.
